Training and certification of lifesaving and river rescue skills, this course conforms to International Rescue Instructors Association standard for level S-2 Swiftwater Operations or Swiftwater Technician recertification, as well as NFPA 1670 criteria for "Swiftwater Operations". Meets USDOI (BLM Reclamation) criteria for river safety preparedness. For this session, the curriculum is tailored to address the needs of guides and other river runners operating boats on southwestern rivers. Course syllabus is available upon request.

When: May 3-5, 2013 (Renewal opportunity for "Class of 2010"-May 7, 2013) **Where:** Pilar, NM (BLM) Visitor Center and on the Rio Grande.

Tuition: \$350 (\$250 for personnel of NMROA-member outfitters).

Prerequisites: Registrants must: 1. certify their physical fitness, 2. posess strong swimming ability. 3. read the 60 page information pre-load (provided upon registration). Minimum 48 hours river navigation experience is preferred.

Equipment: Students must supply their own aquatic thermal protection (wetsuit or dry suit), sturdy, wateroriented footgear, gloves, personal flotation device, thermal headgear, helmet; bring lunches and drinking water (at least 2 liters per day). Rescue SW provides course materials, specialized equipment and instruction. **Instructors:** Steve Harris, John Weinmeister and Harvey King, who collectively have 47

years instructing in the Swiftwater discipline. Past clients include fire rescue agencies, federal agencies and outfitter-guides westwide (references available upon request).

Evaluations: On day three, students will perform the practical skills they have acquired: Swiftwater swims, contact rescues, rope rescue, deploying a mechanical advantage system. Successful performance must be demonstrated in order to receive certification, valid until 2016.

Registration: Will close on April 18, at which time a reservation form and full tuition will have been submitted.

Agenda: Classroom exercises commence promptly at 8:30 am Friday May 3, 2013 at the Rio Grande Gorge Visitors Center, 24 mi N of Espanola on NM Highway 68. Field exercises (Sat-Sun) at river, 8 am to 5 pm. Camping is available nearby in the Orilla Verde Recreation Area.

Course Topics:

Classroom study topics (Day one in Pilar): Written Exam, Review of Pre-course Reading Swiftwater Lectures: Identifying and Mitigating Risk; Scene Size-up, Incident Response Plan, Team Organization. Personal Preparedness; Introduction to Technical Gear. Practice: Throwbag- skills and applications; Basic knots and hitches; Anchors; Mechanical Advantage; Rope Management.

Field exercises and applications (Days 2 and 3 are in/on water):

Safety briefing, IAP, Team Organization.

Hazard Identification and Hydrology.

In-water Self-Rescue, Towed Victim Swims, Tethered Swims ("Live Bait"/V-Lower). Panicked Victim Profile and Response; Cervical Spine Management. Foot/Body Entrapment; Strainer Swim, Tensioned Diagonals. River Search, Lowhead dams, Vehicles. Shore-based skills- (Throwbags, Line Crossings, Wading Rescues). Watercraft-based skills- (Characteristics, Flips, Wraps, 2 and 4 point systems).

Independent Skills Testing and Evaluation & de-brief:

- 1. Class 3 swim,
- 2. Towed Victim Swim,
- 3. Toss throwbag-twice in 20 seconds,
- 4. Build simple MA system (3:1, 4:1).

Candidates will also solve a water rescue thought problem.
