## To Our Neighbors,

My family and I wanted to bring Hotel Zazz to life in the heart of the historic Nob Hill neighborhood because we believe in the revitalization of this historic community and neighborhood. Recently, our organization filed a liquor license as "Zazz ABQ, LLC" and I wanted to take the opportunity to create an open dialogue about our plans. The intent of the liquor license is to operate a hotel lounge envisioned as a speakeasy.

As a long-time resident of the Nob Hill neighborhood, I know the potential this neighborhood has to grow and I want to be a part of it in any way I can. Although my family has owned the University Lodge since 1996, the property is turning a new leaf not only in appearance but how we interact and work with the community around us. We're looking towards the future and I want Hotel Zazz to be a place for generations to come to visit and enjoy within the Nob Hill neighborhood.

We're investing in the security of the property by:

- Installing state-of-the-art high-quality cameras around the property and high traffic areas
- Installing a specialized code lock system, that will keep track of who enters each room and all public spaces
- We've installed a dedicated fiberoptic line for Hotel Zazz, so we aren't sharing the internet with anyone and can protect the security of our guests
- Increasing the security of the hotel and speakeasy by hiring a security company to patrol the property 24/7 to ensure the safety of our guests and staff.

In addition to the above-enhanced security measures, guests will only be able to access the speakeasy by asking a guest service agent to open the door, ensuring that we know who is entering and exiting the establishment at all times. Individuals will also pass several security cameras when they enter the speakeasy.

Our intent is to have this speakeasy available primarily to our guests, and locals who live in the Nob Hill neighborhood. The opportunities when the larger community will have availability to the services from the speakeasy at Hotel Zazz is when the hotel is hosting events in our small event venue by the pool. The food and beverage services for this will often be sourced from the speakeasy but could also be outsourced from other vendors or restaurants located in the Nob Hill neighborhood (see menus attached).

I want you to know that I hear and understand your concerns about having another bar in the neighborhood because this too has been my home for many years. The speakeasy is only a piece of our vision to create a community gathering space, The Living Room of Nob Hill. A place to stay, play, and enjoy events and bring locals and tourists to Nob Hill, adding vitality and prosperity to the neighborhood.
