## Prescribed Fire Planned on Sandia Ranger District

### Cedro Unit – Pile Burning

#### ***Favorable weather conditions in place for hazardous fuels reduction work***

**ALBUQUERQUE, NM – February 2, 2026** – As previously announced, the Cibola National Forest & National Grasslands (NF & NGs) is planning prescribed fire pile burning operations on the Sandia Ranger District as early as Wednesday, February 4 pending all required approvals. Once prescribed fire operations are implemented, this work will continue as a multi-day operation.

Pile burning is meant to treat slash, like branches, piled by thinning crews with the aim of reducing flammable fuels. The decision to proceed with each pile burn will depend on multiple factors, including snowpack, air quality, ventilation, forecast weather and wind, and resource availability. We use prescribed fire to help reduce overgrown vegetation to help protect local communities, infrastructure and natural resources from wildfires.

Sandia Ranger District Prescribed Fire planned for:

Cedro Unit Prescribed Fire Piles: 15 acres of piles within the Cedro unit in the Sandia Piles Prescribed Fire Plan. The pile burn area is in the Manzanita Mountains. Cedro is located south FSRD 462, east of HWY 337. Smoke may be visible from Albuquerque, Tijeras, Edgewood and Moriarty, NM.

This area may be closed to the public for several days during burn operations for public safety. Watch for warning signs along roads near all prescribed fire areas before and during burns.

Residents may experience smoke during the prescribed burn. For more detailed information about air quality, go to [AirNow](#) online or download the app. Smoke is expected to lift during the day, however, cooler overnight temperatures may cause smoke to settle into low-lying areas surrounding the burn location. When driving, slow down and turn on your headlights when you encounter smoke on the road.

We will evaluate weather conditions in the hours before a burn begins. If conditions warrant, scheduled prescribed fire activities may be canceled.
